NATIONAL CONSTRUCTION INDUSTRY (FEES) REGULATIONS, 2023

IN EXERCISE of the powers conferred by section 29 of the National Construction Industry Act, I, Jacob Hara, Minister of Transport and Public Works, on advice from the Council, make the following Regulations—

1. These Regulations may be cited as the National Construction Industry (Fees) Regulations, 2023.

2.—(1) The fees specified in the second, third or fourth column of the Schedule shall be payable in respect of the matters specified in the corresponding column of the *Schedule*.

(2) The fees for renewal of certificate shall be payable not later than the last day of the Government financial year.

(3) Where the fees for renewal of certificate or any part thereof remain unpaid for a period of more than three months after the due date, a penalty of twenty-five per cent of the fees shall become part of the amount due and payable.
